Financial Report

The August 2011 financial statements were received.

Director's Report

Director Bohrer reported on the following:

- The Countryside Improvement Association donated a watercolor by local artist, Jeanne De Haan, which has been located in the adult services area of the Main Library.
- The traffic light's hours of operation at the civic center campus entrance has been changed to better coincide with our Library's hours of operation.
- The Detroit Museum Adventure Pass (MAP) program has ended. The program will return for a fifth and final year in late May, 2012 as a "virtual" program.
- Youth services coordinator, Jill Bickford, received recognition for an article she authored for the Association for Library Service to Children's official journal entitled *Children and Libraries*.

- The Michigan Court of Appeals ruled in favor of the Herrick District Library indicating that the Library of Michigan doesn't have an implied power to independently adopt rules to govern its distribution of state aid to public libraries and therefore lacks the authority to promulgate the challenged rules.
- The Library's annual report for 2010-2011 has been published.
- After a thorough review by staff of the technical issues involved, the Library will not participate in 3M's early adaptor program for their new eBook lending system.
- The Library has been invited to participate in the West Bloomfield School District's First Annual Family Fun Night on September 23, 2011 to be held at the high school.
- The Michigan Library Association opposes legislation recently introduced on Internet filtering, since existing legislation has been effective. The *Spinal Column* devoted their September 7-13, 2011 issue's editorial column to oppose the unnecessary legislation.
- The Michigan Library Association has prepared a position paper on the elimination of personal property tax and the negative impact on local library funding if not replaced with another source of revenue. Our Library would lose approximately \$120,000 in tax revenue.
- The Walled Lake Consolidated Schools will close Twin Beach and Maple elementary schools at the end of the current school year.
