## **Financial Report**

## **Director's Report**

Director Bohrer reported on the following:

- The State of Michigan has approved our technology plan for the period of 7/1/2011 through 6/30/2014. This plan is required in order to be eligible for the Universal Service Fund discount (e-rate) on our telecommunications.
- The Detroit Tigers Winter Caravan event on January 20, 2011 was a tremendous success with hundreds of people in attendance. The Tigers organization presented the Library with a framed jersey and plaque in honor of our receiving the National Medal.
- *Powerspeak Languages*, a new electronic language learning product is now available through the Online Library.
- The West Bloomfield Township Zoning Board of Appeals has approved an extension to our exterior National Medal signs through May 4, 2011.

- Director Bohrer received the United We Walk Community Leadership Award on Sunday, January 23, 2011 during a ceremony held at West Bloomfield High School.
- The Mayor of the municipality where our Sister Library is located in Japan and his delegation will be coming to the U.S. on business and wants to visit our Library to congratulate us on receiving the 2010 National Medal. The visit has been confirmed for the morning of Wednesday, April 27, 2011.
- Usage continues to increase. Circulation of materials, traffic count and reference assistance is all significantly higher than at the same time last year.
- The most recent attempt to re-authorize the Patriot Act in the U.S. House of Representatives has failed. A version has been introduced in the U.S. Senate which includes a “library” provision requiring a higher level of legal showing for the FBI to obtain library records and patron lists.
- An elected official from Bloomfield Hills has set up a meeting on February 23, 2011 with Director Bohrer to talk in general about library service.

## **Reports—2011-2012 Fiscal Year Budget Committee**

The Budget Committee presented the full Board with a draft of the 2011-2012 fiscal year budget. It is projected that the Library will receive \$4,860,773 in revenue, which is a reduction of \$522,345 over last fiscal year. Revenue from property tax, state aid, contract fees, and penal fines all show decline. Revenues, however, from overdues and replacement fees continue to increase as circulation continues to increase. The Friends

of the Library will make another significant donation to help maintain the materials collection.

Expenses will be reduced across numerous areas including personnel services, supplies, community promotion, utilities, professional/contractual and the materials collection. Every attempt is being made to maintain hours of operation and a strong materials collection which are core aspects of library service. Expenditures total \$4,860,773.
