The Board reviewed the 2011-2012 fiscal year budget in the amount of \$4,860,773.00. The budget reflects expenditures over revenue of \$31,480.00. The shortfall will be taken from fund balance, however, the Committee indicated that the Director will look for additional cost savings within the general fund during the year so the fund balance can remain intact. It will not be possible to make the \$100,000 transfer to the Capital Improvements and Automation Development Fund scheduled in the computer/software replacement plan.

The budget reflects a decline of revenue over last fiscal year in the amount of \$522,356.00. Property tax revenue, the Library's main source of revenue, is projected to decline by 10%. The Personnel services, supplies, professional/contractual, community promotion, utilities, rentals and capital outlay (funds for collection materials) line items have all been reduced to make up for the decline in revenue.

There being no public questions regarding the budget, it will be submitted for adoption at the March 2, 2011 Library Board meeting.

Reports—National Medal Celebration Committee

The Committee reported:

The Board reviewed the timeline for the event and asked that a timeline flyer be developed and distributed as people enter the facility.

Approval of the 2011-2012 Fiscal Year Budget

The Board reviewed the draft of the 2010-2011 budget in the amount of \$4,860,773 submitted by the Budget Committee for which a public hearing was held at 5:30 p.m. on March 2, 2011. Revenue is projected to be down by \$522,345, which is a significant amount that requires further reduction in operational expenditures. A portion of the revenue decline (\$31,480.00) will be covered by fund balance, although the Director will try to further reduce expenditures during the year in order to keep the fund balance intact. It was noted that revenue has declined by 26% over the last three years. Operational expenditure reductions fall into the personnel services, supplies, professional/contractual, community promotion, utilities, rentals and capital outlay (materials collection) categories. The scheduled transfer for the computer/technology replacement plan cannot be made.
