- Representatives from Plante & Moran will attend the August Board meeting to present the audit for fiscal year 2010-11.
- State aid to public libraries in the State of Michigan's FY 2012 budget will remain at about the same level, in terms of what will be received by public libraries. New funding in the amount of \$950,000 has been added to directly support the Michigan eLibrary, which includes MelCat.
- Library staff is researching the new 3M cloud based eBook lending system.
- West Bloomfield Township has issued a request for proposal for engineering services related to the pavement rehabilitation project on the civic center campus. The RFP is due on August 8, 2011.
- First quarter department reports covering the period of April – June, 2011.
