## **Director's Report**

Director Bohrer reported on the following:

- The Friends of the Library are sponsoring an exhibit, entitled *Solve-It Central*, from the Ann Arbor Children's Hands-On Museum in the youth activity center at the Main Library from December 12, 2011 through January 22, 2012.
- The after-hours Book Club event to be held on November 20, 2011 has been cancelled and will be re-scheduled at a later date.
- Demographic information available from the 2010 census is being made available to staff in a comparative chart format to foster discussion on program/service implications.
- The Friends of the Library are holding a fundraiser at the Lodge Restaurant in Keego Harbor on Monday, November 21, 2011.
- Time-Warner will no longer provide new DVD releases to libraries, Netflix and Redbox when made available in retail outlets. There will be a 28-day release delay, which will impact our user expectations.

In addition, Bohrer reported on the November 9, 2011 meeting held with all concerned parties regarding the civic center paving rehabilitation project. Representatives from Nowak & Fraus Engineers provided preliminary information on the results of soil borings. The poor quality of the land, as well as poor drainage throughout the site, contributes to the ongoing deterioration of the boulevard and parking lots. To improve the base material, the cost of the project may increase by 30-40%. The Library's main lot also has a problem with the pavement slope not meeting current ordinance. Our slope is in excess of 6% and the standard is 4%. There is consideration being given to pulverizing existing materials to use as a more reliable base material.

The staging of the project was also discussed, although no decision was made. The entire project will take 3 months and will considerably disrupt traffic/access to the site. It would be best if the work were done in June-August 2012. Board members expressed the need for significant advance notice to library users regarding the staging schedule.

The next meeting of the group is being scheduled for the end of November.

The Director's Report was received.
