# **Financial Report**

## **Director's Report**

Director Bohrer reported on the following:

- The civic center paving project has been postponed until next year as indicated in the synopsis for the February 6, 2012 Township Board meeting. Bohrer did address the Township Board at the meeting indicating the Library was ready to move forward this year and had worked out all internal issues, including programming and budget. There was discussion of the language in the synopsis and Bohrer was asked to see if it could be changed to clearly indicate that the project was not being postponed due to issues with the Library and Friends of the Library programming.
- The final season for the Museum Adventure Pass (MAP) will be held starting Memorial Day weekend through Labor Day weekend of this year.
- Re-districting in the Walled Lake School District will result in the majority of West Bloomfield residents attending Oakley Park, Keith and Pleasant Lake elementary schools. Youth services staff will attend the kindergarten open houses on March 6, 2012 at the three schools with a display on Library services.
- The Library will be retro-fitting and changing lamps in some lighting fixtures in order to save on electrical costs at the Main Library. The primary savings will come from changing HID to CFL, which are located in the lobby and down the clerestory area.

# **Natural Gas Supplier Services**
