Director's Report

Director Bohrer reported on the following:

- The Westacres Branch has been fully converted to the new RFID tags and equipment. The Main Library should be fully converted within the next 2-3 weeks.
- Representatives from Plante & Moran will be on site beginning Monday, June 16, 2014 to conduct the annual audit.
- Plans are being made for the youth delegation from Awaji City, Japan at the end of July.
 There will be 8 students and 2 chaperones. The visit will include an additional day this year.
- Our youth services coordinator met with the principal of Roosevelt Elementary to discuss possible collaborative activities to support the population at the north end of our service area and at-risk children.
- The Institute of Museum and Library Services is entering into a year-long collaboration with the BUILD initiative, leaders in state and early childhood systems and policies, to better understand how museums and libraries can be tapped to provide, advance, accelerate or scale early learning opportunities for children, families and communities. Director Bohrer, along with a representative from the Library of Michigan, was asked to

serve on the working group for the project. Michigan is one of the five pilot states for the project.
