Director's Report

Director Bohrer reported on the following:

- Year-end usage statistics reflecting the entire spectrum of operations.
- A warning letter has been sent to the parents of 2 individuals due to violations of the Library's Rules of Conduct.
- The Oakland County Road Commission will be replacing the light poles at the intersection of Farmington Road and Walnut Lake Road this fall which means our fiber will need to be moved to new poles and elevated above 25 feet.
- The scope of work for upcoming capital projects which includes the back-up generators at both facilities, new boilers at the Main Library and six new study rooms at the Main Library.
- A permanent injunction was signed by a federal judge in U.S. District Court against the section of PA 269 prohibiting voter education up to 60 days prior to a millage election.
- A meeting with representatives from West Bloomfield Parks and Recreation regarding their interest in potentially pursuing additional millage for a community center on the civic center campus.
- Misrepresentation by a Township employee to the Township Board regarding a conversation with the Library Director that never took place regarding the level of satisfaction with the security system.
- The Township's final tax settlement payment was incorrect, as pointed out by the Library's finance director. The Library is now being invoiced to return the overage.
- The Library has received a public relations award from the American Library Association for summer reading promotional materials.
