- The new strategic plan infographic is now available to the community and will be included with the endowment solicitation in November.
- Our IT staff placed first in Innovative Interfaces "hackathon" which took place during the 2019 Innovative Interfaces User Group meeting last month.
- The MMRMA insurance coverage was renewed for the coming year. The net asset distribution to be received from them in this fiscal year will be \$11,439.
- Additional shelving has been installed in the storage room in the basement for use by the Friends of the Library to accommodate book sale materials.
- Two of our library publications—*Library Resources for Educators* and *Smart Start: Building Baby Brainpower*—have received an award from the American Library Association as part of the PR Xchange Competition.
- The Township is planning to resurface the boulevard and has requested that the Library pay our portion.
- The IT staff is working with our telephone provider to conform to the Michigan's E911 law, which is required for multi-line telephone systems in facilities larger than 7,000 square feet.
