Director Bohrer reported on the following:

- The Michigan Library Association has developed substitute language to amend the Library Privacy Act which will be sent to the legislators who proposed Senate Bill 611.
- Additional single person study seating will be installed at the Main Library by the end of the fiscal year to meet demand.
- Marketing screens which provide promotional messaging are now operational at both facilities.
- The Library celebrated the life and vision of Dr. Martin Luther King, Jr. on Monday, January 20, 2020 by offering three well-attended programs, two of which were family-oriented.
- The Library initiated a new reader's advisory opt-in service called *Personal Picks*, which provides users with recommendations based on their reading history.
